Dear Customer,

We are writing to you on behalf of World Nomads Inc (1585422) which trades as World Nomads (WN) to let you know that WN has agreed to transfer its U.S. travel insurance business to iTravellInsured, Inc. (NPN #8247849) (**iTravellInsured**) as part of the [global sale](#) by nib Travel Pty Ltd of its World Nomads travel insurance business to Sirius International UK Holdings II Ltd (**SiriusPoint**) provided certain conditions are fulfilled.

iTravellInsured is the travel insurance brand for International Medical Group, Inc. (**IMG**), a wholly owned subsidiary of SiriusPoint, and is licensed to sell travel insurance throughout the U.S., with its registered office at 9200 Keystone Crossing, 8th Floor, Indianapolis, IN 46240. Conditions

The transaction is subject to regulatory approvals and other conditions, and nib and IMG are taking the necessary steps to satisfy these as soon as practicable.

Timing

We anticipate receipt of regulatory approvals and satisfaction of all conditions by the end of July 2026 enabling us to complete this transaction between August 31, 2026 and December 1, 2026. Please accept this as notice that this transaction will occur provided all approvals and conditions are satisfied in no less than two months' time.

If completion does not occur, we will provide an update to you.

What this means for you:

- Upon completion of the transaction, your plan and any new World Nomads plans that you purchase will be with IMG, who will continue to sell the World Nomads product in the U.S.
- Your insurance coverage will continue to be underwritten by United States Fire Insurance Company and administered through Trip Mate, a Generali Global Assistance & Insurance Services Brand.

- Your insurance benefits, coverage, and plan terms will not change as a result of this transaction.
- You do not need to take any action unless you wish to contact us regarding the transfer of your personal information, as described below.
- Your existing claims, customer service inquiries, and plan servicing will continue without interruption during the transition.

Your information

As part of this transaction, your personal information and plan details (if applicable) will be securely transferred to IMG so that the services that have been provided to you can continue. Your information will be handled in line with applicable U.S. federal and state privacy laws. Section 2.2 of our [Global Privacy Policy](#) provides the terms for which the transfer of regulated activities can occur. Your personal information and plan details (if applicable) will be securely transferred to IMG unless you contact us to advise that you do not wish for your data to be transferred, noting that may impact your plan (if applicable). If you choose not to permit the transfer of your personal information, we may be unable to continue administering your plan or providing certain services.

We want to reassure you that this change will not affect the service you receive, and any existing queries or complaints will continue to be handled without disruption.

Additionally, the contact details provided to you in your plan documentation will remain unchanged post completion of the sale of our World Nomads business to SP.
